## OLE Health PGY1 Residency in Ambulatory Care Pharmacy Practice

**Pharmacy Services:** Pharmacy services include comprehensive medication management, anticoagulation monitoring, blood pressure monitoring and insulin/injection teaching. The clinical pharmacists are involved with specialty clinics including diabetes and chronic pain management.

**Educational Experience:** The OLE Health resident typically spends 3-4 days in clinic, and 1-2 days in administration/research/teaching. On average, clinic days usually have 9 patients with 2-3 comprehensive medication reconciliations. Residents are also responsible for answering daily drug therapy questions from providers, participating in journal club/topic discussions writing and editing the newsletters throughout the year and providing in-services to the health care team. As the year progresses, residents are given more responsibility precepting students and independent involvement in our clinics. There is also at least one quality improvement project, but the resident may be involved in more administration processes if desired.



### **Qualifications**

The applicant must have a Doctorate of Pharmacy (PharmD) degree from an ACPE accredited pharmacy school (or in process of pursuing accreditation) or a Foreign Pharmacy Graduate Equivalency Certificate (FPGEC) from the National Association of Boards of Pharmacy (NABP). Applicants must also have U.S. citizenship or Green card and be eligible to sit for the examination for CA pharmacist licensure. **Ability to speak fluent Spanish is preferred but not required.**

### **Application**

Deadline for applications is January 5<sup>th</sup>, 2018. Applicants should be ready to sit for the board exams on or before July 31, 2018. National Matching Service (NMS) code: 237513
