# PGY1 PHARMACY RESIDENCY ACADEMIC TRACK

## THE HOSPITAL SYSTEM

Founded in 1876, Santa Clara Valley Health & Hospital System (SCVH&HS) is a nationally recognized public health care facility that provides a full range of **acute care, intensive care (Level I Trauma Center), rehabilitation, and ambulatory services**. Located in San Jose, California, the hospital serves as a **county, teaching, and safety-net hospital**. The hospital's mission is **"Better Health for All,"** providing high quality, cost-effective medical care to all residents of Santa Clara County, regardless of their ability to pay.

## PHARMACY SERVICES

The pharmacy department offers a wide array of comprehensive services in both the inpatient and ambulatory setting:

- The inpatient pharmacy opens 24/7 to serve 574 beds and has clinical pharmacists in areas such as **infectious disease, critical care, and emergency medicine**.
- There is a vast network of **11 outpatient pharmacies** located throughout Santa Clara County.
- Ambulatory care pharmacists specialize in managing various diseases, including **anticoagulation, diabetes, and heart failure**.
- All services utilize **HealthLink, a version of EPIC** (computerized physician order entry and electronic medical records).

## RESIDENCY PROGRAM

The pharmacy residency program was founded in 2004 and received **full accreditation by ASHP** in 2005.

- Activities include going through clinical rotations, precepting APPE students (Touro, UOP, and UCSF), attending conferences, completing a longitudinal residency project and committee work, delivering a continuing education program, and staffing
- The program is expanding! For 2016-17, SCVMC welcomed **10 PGY1 pharmacy residents**, one of which is the academic track resident in collaboration with Touro University.
- Academic track residents earn a teaching certificate through Touro University by participating in activities such as leading class discussions/workshops and evaluating oral exams.
